SULGRAVE PARISH COUNCIL MINUTES OF A PARISH COUNCIL MEETING HELD ON THURSDAY 12TH JUNE 2014 IN SULGRAVE CHURCH HALL AT 7.45PM

Councillors Present

1a. Apologies

Cllr's Russell, Harding and Pollak

1b. Chairman's signing of Declaration of Acceptance of Office Form

This was signed and the Parish Clerk will file.

2a. Declaration of Interests

No interests were declared.

2b. To approve and sign minutes of the meeting of 8th May 2014

The minutes could not be approved as only one councillor (namely Cllr Roberts) was present at this meeting and the last meeting. To be carried over and approved at the next meeting.

2b. Matters Arising

Dog fouling - This was reported to SNC who have sent dog fouling notices. Cllr Roberts to put them up around the village where appropriate.

Fly Tipping - This was reported to the Street Doctor. SNC have advised that contact details of the offender were found in the dumped rubbish and they have been interviewed. SNC are deciding whether to take any further action. The Parish Clerk has spoken to George Metcalfe who reported the incident to the Parish Council.

HS2 Petitions - The Parish Clerk wrote to MP Andrea Leadsom to complain about the short notice to file a petition. Mrs Leadsom has replied and written to the Secretary of State for Transport to express the concern. There will be another opportunity to petition Parliament when the Bill reaches the House of Lords.

Releasing of Covenant relating to The Old Farmhouse and The Old School House (now the village shop) - The Clerk has signed the documents and returned to Brethertons Solicitors.

3. Councillors Reports

Cllr Roberts spoke about the quality of the grass cutting which was raised at the last meeting. A request was made to cut extra verges of which there has been no extra charge. The Parish Clerk contacted Philip Daynes about cutting much shorter so that the cuts last and including the extra verges. There are other verges such as in Park Lane which are meant to be strimmed twice a year but have not been cut at all. Mrs Lloyd also emailed the Parish Clerk about the path up the churchyard which is very overgrown.

Action: The Councillors to visit the churchyard after the meeting and Cllr Roberts to speak to Philip Daynes.

Cllr Powell reported an overflowing storm drain in Manor Road despite the weather being very dry recently.

Action: The Parish Clerk to report to the Street Doctor.

4. To discuss the progress of the street lighting project

Cllr Roberts has produced a specification which has been typed up. The Parish Clerk has sent the tender to four companies and advised that replies have to be submitted by 4pm on 31st July. There is no Parish Council meeting in August because of holidays but the councillors can look at the tenders in September. The Parish Council will use August to consult the village via the newsletter.

Councillors discussed how the project will be funded. The best way is through a Public Works Loan as it is such a big project.

Action: The Parish Clerk to investigate the loan details and process for investigation.
