
Sulgrave News



Between some Turbines and a Railway!

It seems that Sulgrave and the surrounding villages are being steam rollered into the 21st century, with turbines to the right and HS2 to the left. As a rail enthusiast I half expected the line to come somewhere close, but I didn't realise how close, yards from houses in Greatworth! Sulgrave village should avoid the worst of its physical impact, it being over the brow of the hill, and in a deep cutting at its nearest point. However, as proposed, it will split the two villages, effect the countryside in between, and cause a reduction in property values.

I would say that this is a 'Preferred Route' and not set in stone, and although difficult to challange, a case could be made that a route further west would serve the commuity better. Such a route could allow an intermediary station near Bicester, providing access from the M40, A34, and connection with the proposed reinstated East West rail route between Oxford and Cambridge. If the people of Kent, on the EuroStar route can have High Speed commuter trains stopping at Ashford, why cannot those in Oxfordshire, Buckinghamshire and Northamptonshire get some access to this line which is going to plough through their countryside. From Bicester, the line could then run northwards in the M40 corridor, where an occaisional HST would add little to the existing noise levels.

I would also say that Arup, the engineers whose report forms the basis of this proposal are not infalable! Take a look at their drawing for this part of the line, HS2-ARP-07-DR-RW-03117, and you will notice that on the cross section, there is an 'Overbridge' where the line crosses the B4525 Welsh Lane (correct), while the plan of the line indicates an 'Underbridge' (a bridge below a cutting; I think not)! A silly little mistake, but what other mistakes and false assumptions lie deeper in the report on which the case for this route is based?

The above is personal point of view, and I have avoided the debate about whether the line is worth building at all.

If you wish to contribute to the discussion and have your opinion heard, look out for information on the village website, and elsewhere, about the many meetings that are going to take place in the coming months.

My dear hibby,

I would be most grateful if you could transmit this message to the good people of Sulgrave. Being a member of the Advisory Council of the Manor Trust, you are well aware of the strong feelings we all have for the beauty of your village, and the need to ensure that nothing is done to mar that in any way.

For many months now, we have been most anxious about the state of the roof of the two houses in Sulgrave owned by the Trust – Kiln Farm and Manor Cottage. It is a matter of very great concern to us all that the tenants in both properties should not suffer from damp, or rainwater, due to the thatches leaking. The estimates for complete re-thatching of both properties were enormous, and the truth is that we do not have anything like the amount needed to get the jobs done. As Chairman, I spend a great deal of time trying to get donations to meet the running costs of the Manor; in fact, I am shortly off to America, where I shall spend the whole of Aprii speaking at events aimed at fund-raising for Suigrave. Board members are determined to do everything possible to keep the Manor open – this is of great historical importance, and the one visual embodiment of the special link between Britain and America.

Thus we have been torn between determination to protect our tenants, and the fact that the most acceptable solution (re-thatching) is at present impossible to afford. Using temporary darkish strong green plastic was, according to the expert advice we sought, the best way out of the difficulty. We know this is not ideal. We are very sorry if this offends any residents of the village, and indeed would be extremely grateful if anyone there could come up with suggestions as to how we could do better.

Draft Notes from Parish Council Meeting held 11th March 2010

Introduction

The Chair welcomed everyone to the meeting.

Confirmation of minutes of last meeting held on 18th February

The minutes of the last meeting were agreed and signed as a true record.

Councillors Reports

Community Speedwatch

At the last council meeting a discussion took place about a pole being placed on the Stocks Area and it was agreed this was not the best place for it. The pole then appeared in the ground on the following Monday. Cllr Powell had been told the flashing sign would be in place from 5th April to 2nd May but had not been told the pole would be erected five weeks beforehand. Cllr Powell contacted Pc John McQuaid who then spoke to Steve Barber at NCC and there seems to have been a lack of communication between both of them. Two other places were suggested for the pole, outside Eagles House or on the driveway of Hill Cottage but it was felt these are not suitable either. It was agreed the Clerk should write to Steve Barber at NCC to advise the pole must be removed as soon as possible. Cllr Powell has agreed to continue with the speedwatch activity.

Pocket Park

There is a meeting on 18th March with the facilitator to complete the second part of the application form. A meeting has been held with George Metcalfe (GM) to discuss the changes that are going to be made and funding opportunities for the pond.

This will include a walkway around the pond, disabled access, a dipping area and new fencing. GM was happy about the suggestions that were made.

A note will be put in the next newsletter asking for villagers to join a working party on a regular basis as GM is unable to do the work on his own now. Chris Coverley has spent 5 hours cutting hedges and thanks was given to him. There will be drawings on display for everyone to see at the Castle Green open day in May.

Castle Green

In November Cllr Pollak reported that the Castle Green Committee (CGC) had accepted practical completion for repairs to the wall round the Green and Underwood and Weston had been paid the remainder of the contract sum, less 2.5% retention. The wall will be inspected thoroughly in April and any defects will have to be put right by the contractors before the final payment is made. The figures for the extras have not yet been agreed

and discussions are still ongoing between CGC, the Rhodes Partners and Underwood and Weston.

Plans for the May Fair Event on 2nd May are underway and it should be an enjoyable day. Representatives from all the funding bodies, district and county councils and all those who have contributed to the success of the Restoration Project will be invited. The Wildlife Trust will be helping children to make nest-boxes for the Green, 'Saxon' Historical Enactors will attend, and the traditional Historical Treasure Hunt will take place on the Castle Mound. Other attractions will include the Eydon Mummers, Morris dancers, a beer tent, a barbecue and teas and cakes. Several stallholders have come forward already.

There is an increasing problem with dog fouling on Castle Green and the Committee is working what can be done to prevent it.

Undergrounding

The Chair advised that white lines have appeared in Church Street but it is not known who has put them there. The Chair has asked Central Networks if they are planning any more underground work and they have advised they are not.

Action: The Clerk to contact MGWSP to see if they know what work is to be done.

Dog Fouling

The problem is still continuing. From the floor, Mrs Prior noted that dog mess was found on Castle Green the previous weekend. There are several solutions being considered. An exclusion control order could be placed on Castle Green but this is not a preferred solution as many people use the area. Alternatively dog waste bins installed. Dog waste bins cost between £200 and £300 (installation is extra) and collection is £2.50 per week to empty each bin. The grass cutter also experienced problems last year with dog mess. A leaflet was distributed around the village two years ago to consult on the installation of Dog waste bins and the results showed most people are against bins.

Action: It was agreed there will be a clean up operation on Castle Green as soon as possible and the Castle Green Committee will put notices up at each side of the park. Another note will be put in the newsletter.

Finance Report

Cheques for approval

The following payments were approved and cheques raised accordingly:-

£100.00 to Sulgrave Parochial Church Council (church clock maintenance)

Mr Prior advised that major repair work is needed to the Clock Face and major fund raising will be needed. More details will be in the next newsletter.

Planning Applications

A decision notice had been received for:-

S/2009/1292/FUL, single storey rear extension at Blackbird Cottage, Little St. Approved by SNC.

Two new applications had been received since the last meeting:-

S/20100190/FUL, two detached dwellings with outbuildings and carport. (revised scheme to planning permission S/2009/1276/FUL) at Dial House Farm, Magpie Road

S/2010/0075/FUL, 60M high wind monitoring mast (temporary for two years) on land between Greatworth and Helmdon. The Parish Council had objected to this as there is no provision for a boundary fence around the perimeter of the installation. From the site map the guy line anchors are shown within 10-12M of a public footpath which may be used by the public at night. There should be a boundary fence with adequate warnings or the mast be relocated to a point further from the public footpath.

Broadview Energy Ltd held a public exhibition on 2nd March 2010. Details were given about a community benefit fund and a sum of money which is given for the duration of the wind farm. The money will be of community benefit and a local charitable trust is set up to manage the fund.

From the floor Mr Wootton advised that Helmdon have formed their own action group and are meeting on 12th April in the Reading Room at 7pm. Presentations will be made by Broadview Energy, CPRE and the Local Planning Authority.

Enertrag Planning Application

Enertrag have provided an update on their application. They have advised their public consultation will be at the end of April. They have set up a community fund for each project that is developed and the set amount available to the community each year is approximately £15-20K. Any community group or organisation can apply to the scheme for an amount. The closest villages such as Sulgrave and Weston will be given priority although all surrounding villages approximately 5km from the site will be considered. The money is always allocated to community schemes for wider benefit rather than individual projects.

It is expected that a planning application will be submitted at the end of the year (approx Nov 2010). Enertrag are aware of the Broadview development proposal and will be working with the LPA and developer to co-ordinate the cumulative assessment in all respects including noise/landscape and visual assessment. A full consultation will be undertaken with all parish councils surrounding the site. In respect of photomontage locations, viewpoints will be agreed with the District Council. Enertrag have agreed to discuss any noise concerns in the future with the Parish Council.

The Chair concluded the discussion by referring to the briefing note from Daventry District Council on large scale wind turbines and wind farms. If more than half of the councillors declare an interest the Parish Council has to seek dispensation from SNC so that they are allowed to respond to the wind farm application on behalf of the community despite their interests. This is something for the councillors to think very seriously about.

Correspondence

The Chair spoke about the proposals for the High Speed Rail Link from London to Birmingham and the route which will pass very close to Sulgrave and the surrounding villages. The route has just been published and it was agreed the links to the internet site would be set up on the village website for everyone to see more clearly.

Open Forum

Mr Prior spoke about the current transformer behind the shop which serves the properties in Magpie Road. 2 more houses have been built behind the shop and 5 at Dial House Farm and the question was asked if the power supply from that transformer is still adequate. The Chair agreed to email Central Networks and ask them for advice.
