n Saturday 23rd October, at the third time of asking, twelve stalwart members of Sulgrave History Society met up at Stuchbury Hall Farm to field walk the lost village of Stoteberie. With the kind permission of Joan and Michael Tims we were to discover first hand (or should it be foot) the explanation of all the humps and bumps surrounding their lovely farmhouse.

Having gathered around their enormous kitchen table with plans of the whole site, I was able to outline the interpretation of its topography. This was based on the researches of Field Archaeologist Patrick Leonard and his assistant Jean Walker from 1994, the map from Brian Davison's (the archaeologist who excavated Sulgrave Castle) article on Stuchbury and the writings of our own, much missed, Peggy Fonge, who with her husband Les, farmed the area for many years.



Having digested its history we then walked over the site. Firstly to the top of the village, then the Fish Farm itself, still with its channels and springs running. Finally, we walked down the old main street - part of an ancient cross-country trackway - and explored the house platforms of the main village. A good hour was spent inspecting, sometimes in the company of inquisitive young "stote" (calves), every aspect of the old village.

Having completed our exploration we were welcomed back to Joan and Michael's farmhouse kitchen to be treated with tea and an array of lovely cakes! It proved to be an excellent afternoon's tramping. We were only rained on once, with bright sunshine being predominant. Thanks are due to our hosts especially and to those who came along. Hopefully they now have a good understanding of the humps and bumps that make up much of the landscape around Stuchbury Hall Farm.

Draft Notes from Parish Council Meeting held 4TH November 2010

Confirmation of minutes of last meeting held on 7th October

The minutes were agreed and signed as a true record.

Matters Arising

Biodiversity Survey - The Clerk noted the cost of the biodiversity study, advised by Cllr Osborne at the last meeting and referred to on page 3 of the minutes of 7^{th} October, should have read £200.00 and not £250.00.

Housing Survey - This was delivered with the newsletter one week ago. Thanks was given to George Metcalfe and the team of people who help to deliver it.

Guest Speaker, Mr Alan Seeds (HS2 South Northants Action Group)

Mr Alan Seeds, the Culworth PC representative for HS2 attended the meeting to give an overview.

HS2 is the next stage, after the Channel tunnel link to St Pancras (HS1) to extend a high speed network northwards. It will begin at London Euston and run via Birmingham to Manchester and Leeds. Links to Heathrow and the HS1 route are planned. It will run at speeds up to 400kph (250mph) on an entirely new route. The business case prepared for the Government proposes a train every 5-6 mins on average each way for 16 hours a day. Route 3 is the preferred route and is largely fixed. However a process of minor adjustment has already begun to meet various concerns.

The latest version has moved the route further away from Brackley and small adjustments near Lower Thorpe, Chipping Warden and Boddington are also proposed.

The Governments case for HS2 is based upon three targets, Capacity, Connectivity, and Sustainability. All of these have shown to be wrong. HS2 Key Events

- The preferred Route 3 was published in early 2010.
- The Exceptional Hardship Scheme is published and underway.
- The Route 3 "mitigation process" is being conducted.
- A route beyond Birmingham is now being developed.
- The consultation process is due to start early in 2011.
- Route 3 will be finalised by the end of 2011.
- The final route will then be "safeguarded" and a hybrid bill introduced in 2013.
- Construction is being scheduled to begin ca. 2017 and completed 2025.

The effects of HS2 and the activities to oppose it Areas close to the route

Key effects will be major disruption during construction, severe noise intrusion from the trains and property blight.

Areas outside the immediate zone

Road transport across the route will be severely disrupted during the construction phase (7-8 years in total). The total costs of £33billion (sure to rise) will have to be found from other budgets. An immediate spending of £800m for the next few years has recently been announced and this is expected to grow to a total of more than £1billion during this parliament

Summary of actions to oppose the development

- A substantial rebuttal of the business case has been presented and not substantively challenged by the government
- The sustainability case has been criticised but until the Government publishes its report, this cannot be formalised
- A wide range of media and protest events have been undertaken, in particular challenging the Secretary of State directly
- An MP Lobby Day has been undertaken on the 25th October
- A Judicial Review is under consideration
- A petition for 100,000 signatures is underway to trigger a Commons debate

The aim of South Northants Action Group (SNAG) is to represent the villages and businesses of South Northants, challenge the business and environment basis for HS2 and fight for compensation and mitigation if HS2 goes ahead.

This is being done by keeping villages informed and involved, liaising with national and district action groups, working with councils to ensure their active support, supporting the political campaign and organising district protest events. SNAG can help local villages by being the hub of information on HS2 progress and helping villagers protest for the cancellation of HS2.

This was followed by a question and answer session.

The Chair concluded the discussion by thanking Mr Seeds for coming to the meeting. The Parish Council would like to be kept informed and it was agreed that written information would be passed through Mr Ken Christy. Mr Seeds then left the meeting.

Finance Report

 a) To approve the following payments: <u>Cheques for approval</u> £50.00, Donation to Brackley Area Volunteer Car Service £208.75 to EON (electricity) £329.00 and £258.50 to R D Landscapes Ltd (grass cutting)

These were proposed by Cllr Pollak and seconded by Cllr Waite.

Planning Applications

One new application had been received since the last meeting:

• *S/2010/1271/FUL, Construction of 4 bay car port building with home office and storage above at Dial House Farm, Magpie Road.* Currently in circulation.

Open Forum

Mr Christy spoke about the possible disruption to electricity supplies in December by Central Networks. He asked the Parish Council to chase Central Networks as no further update had been given since the last meeting.

Mr Metcalfe spoke about Pocket Park and was sorry that Cllr Osborne was not present. There are eighty pocket parks in the County and Sulgrave is the only park that does not have a Pocket Park Warden. The village have been without a warden for ten years and in his opinion it was a disgrace for a quality council. Two letters have been sent to the Parish Council and have not been replied to. Requests had been made for a warden in previous newsletters but they were half hearted and there was no information given about the job. Mr Metcalfe explained that Pocket Parks are local and were started in the 1980s. The object was to encourage parishes to acquire pieces of land to create public open spaces and conserve nature. Pocket Parks are meant to be nature reserves and not childrens play areas. Most other Pocket Parks do not have play equipment. Money was raised by an active group of young parents and they raised £4.5K. Duties involved clearing the pond and hedge trimming. No actual gualifications are needed, just to be enthusiastic and be able to learn. He suggested that a full page advert is placed in the next newsletter. The Chair replied that a small group of people have come together to help raise money and bring Pocket Park back to how it was. A consultation document was put out to ask villagers for their views and most asked for a nature/pond area and play area. The Chair requested that the last notice be put in the newsletter. The first step for the Pocket Park Action Group is to get a Pocket Park Warden. Mr Metcalfe asked what the arrangement was for collecting rubbish from the bin which can no longer be used. He advised the meeting that he emptied it over a long period of time. The Chair replied it had been boarded up and people are encouraged to take their own rubbish home. This will be put on the agenda for discussion at the next meeting.

Mr Wootton gave an update on the Broadview planning application. The Case Officer is Chris Johnson and they have requested more information from Broadview before being able to put out to consultation. Mr Wootton has agreed to supply a leaflet from the Action Group giving details of the next meeting date and where the planning application can be viewed.
