



## DEMISE OF THE SULGRAVE WINDFARM

Earlier this month, the energy company Enertrag, which had planned to erect nine 410 foot wind turbines between Sulgrave and Weston, sent written notification to Sulgrave Parish Council that they had cancelled the project. Enertrag, having reviewed the viability of all their projects, concluded that the Sulgrave/Weston scheme was unlikely to receive the requisite planning permission because of "issues of cultural heritage" and "issues of landscape".

The Sulgrave And Weston Windfarm Action Group (SWWAG) have also received notification from a spokesman for All Souls College (which owns the land upon which the windfarm was to be built) that the College has no further plans for any similar developments on this land within the foreseeable future.

SWWAG intends to hold a full meeting of its members and supporters before the end of the year to discuss the dissolution of the group and to decide upon the most appropriate use of the funds that they have raised. One proposal is that the funds be donated to the Helmdon, Stuchbury and Greatworth Windfarm Action Group (HSGWAG) which is fighting a plan by the company Broadview to construct a windfarm between Greatworth and Helmdon. The five 410 feet high turbines of this scheme would all be clearly visible from many parts of the village, especially from houses with windows and gardens facing southwards. The turbines would completely dominate the southern skyline as seen from Castle Hill, the Old Windmill and other viewpoints and would be an overwhelming presence to those using favourite footpaths and bridleways southwards towards Helmdon and Greatworth. SWWAG believes that many of the arguments which were levelled at the Enertrag plan apply equally to the Broadview windfarm and its members are thus giving full support to HSGWAG in their battle to defeat the scheme.

#### Draft Notes from Parish Council Meeting held 2<sup>nd</sup> September 2010

#### Introduction

The Chair welcomed everyone to the meeting. A minutes silence was held in respect of Jean Garton who had recently passed away.

#### Confirmation of minutes of last meeting held on 6<sup>th</sup> July

The minutes were agreed and signed as a true record.

#### Guest Speaker, Mr Montagu-Smith of CPRE Northants

Mr Montagu-Smith thanked the Parish Council for the invitation to attend the meeting. A letter dated 30<sup>th</sup> May from CPRE had been sent to the Parish Council as controversy had arisen surrounding the policy of the Northants branch towards the HS2 project. Mr Montagu-Smith stated the CPRE is unreservedly committed to defending the environment and quality of rural life in South Northants in the face of the project and the CPRE are determined to work closely with all the communities which would be affected by them in defence of the countryside and everyone living it, while stopping short of opposing the principle of High Speed Rail. Mr Montagu-Smith felt this was the opportunity to talk more about the CPRE Position in an open meeting.

Mr Montagu-Smith stated:- The current position is that the major political parties have committed to HS2 and the new coalition government are looking to accelerate it. Consultation will be at the end of the year and the route defined then. CPRE nationally support HS rail as it will reduce air travel, road travel and relieve railway traffic. The CPRE care about the environment and have looked at where

they can apply their own influence and see what the real effects would be on affected communities. They do not see it as being constructive to attempt to block HS rail. This view is experienced by the first high speed rail built in Kent. It was opposed at the time but was still built and the CPRE branch in Kent played a significant role in reducing the impact, securing noise reduction and screening.

The CPRE see four issues

1. Speed, The government intention is to build the fastest rail system in Europe, this is not regarded as necessary.

2. Blight -. The blight footprint will be large. There is scope to raise an argument the compensation scheme should be extended

- 3. Compensation this is an issue and the history of the Kent story is important.
- 4. Landscaping, pressure can be brought to bear to minimise the impact on areas close by.

The meeting was opened for questions:-

Mrs Burke asked where the money would come from to pay for it? Mr Montagu-Smith stated he believed finance is not an issue as the project will be financed by the private sector.

Mr Christy expressed his disappointment by the policy taken by CPRE. The CPRE should not accept it and stand up and protect the blight of the landscape. People like the convenience of cars and will not stop using them because there is high speed rail. He felt that CPRE will lose members. Mr Montagu-Smith replied they had lost one already who did not agree with their principles. Mr Montagu-Smith replied that the money is there and the project will have government backing. There is a consensus from all political parties and the CPRE do not see how they can fight against it in the knowledge they will fail. They have to look at which battles they are going to fight and choose the ones they might have success with.

The Chair was concerned about the blight and the cut and fill principle which will be applied and more consideration should be given to tunnelling. Speed is a valid point but the operators should look at expansion of existing lines. Mr Montagu-Smith said the CPRE have looked at the wide range of options considered by the old and new government. They have looked at high speed and enhancement of existing systems but high speed is wanted.

Mr Prior spoke about the suggestion of an interim station in Brackley. Mr Montagu-Smith replied there has to be a collateral advantage available to areas that are not benefiting from the high speed rail. There would have to be justification for another station in this area. Mr Prior felt the 2020 convention on pollution was the reason for bringing the project forward. He felt that the answer was to reduce speed and manipulate the line around sensitive areas.

Cllr Osborne spoke about what CPRE actually stands for. There are lots of rural villages and they should be focusing on that. Mr Montagu-Smith agreed and a lot of work was done last year to make the smallest number of impacts and to stop countryside being unspoilt. Their main objective is to protect the rural landscape and communities and they are not in favour of any particular route but must find practical ways to reduce the impact.

Cllr Pollak thought that at a recent meeting with MP for South Northants, Andrea Leadsom, had said she would investigate the questioning of the viability of high speed rail. Mr Montagu-Smith felt that testing the viability is a larger question.

The Chair summarised by noting they understood the position of the CPRE and thanked Mr Montagu-Smith for his contribution to the meeting. The issues recognised by all are speed and noise, the blight, adequate compensation to be more fairly distributed, and in the event that HS2 appeared to be inevitable the need to reduce visual impact and noise.

Mr Montagu-Smith concluded by noting that once they know the defined route they will get as much information as possible of those who will be affected with neighbouring counties. He was sorry that their position did not satisfy everyone but noted they would be available to help where possible. The Chair thanked him for coming and Mr Montagu-Smith left the meeting.

#### Councillors Reports

#### <u>Village Newsletter</u>

Tom Cockeram had been invited to the meeting as he had been editor for six years until recently standing down. The Chair thanked him for all his work as the newsletter is an important means of communication. The Chair advised that Janet Smith and Colin Wootton have taken over the roles.

#### Wind farm applications

A letter had been received from Enertrag to note the group has been restructuring its European operations and conducted an internal audit of all work and projects.

They have decided not to pursue a wind farm development at Weston due to initial environmental assessments of the site being conducted and covering a number of issues including cultural heritage. They do not wish to commit further investment in a site which could be finely balanced in planning terms.

The Chair thanked the Action Group for all their hard work over the last year and noted he was very pleased with this outcome. Mr Prior asked if an undertaking can be made with the landowner so that the company do not reapply again. Mr Wootton replied the landowner did not have any option in the beginning.

#### Community Speedwatch

PC John McQuaid has visited and advised the speeding van (used on Welsh Lane) will be visiting the village on certain occasions. A request will be made for each existing volunteer to find two more volunteers so that this exercise can continue. Cllr Powell repeated that she would be happy to help out still.

#### <u>Castle Green</u>

Cllr Pollak gave an update on the Castle Green Restoration Project.

#### Wall Rebuilding

In June the builders Underwood and Weston sent an email refusing to return to site to complete the repairs necessary following the 6 months retention period. In July a formal letter was sent to them, requesting that they confirm in writing they had no further claim on us. To date there has been no reply.

They amount U & W could have received is:5% retention sum£1087Extras (contingency)£1896Total£2983

There was also an agreement that they could have been paid an extra contingency amount of up to  $\pm 3000$ .

Rhodes Partners have found another builder, Paul King of Wappenham who quoted £5500 plus VAT ( $\pounds$ 6462.50) to remove all the capping and mortar and replace it with more stones which would be closer together and therefore much more robust. After protracted negotiations with the Heritage Lottery Fund, the committee have been given permission to appoint Kings to carry out the work, and they will be commencing work in mid October.

#### <u>Sign Boards</u>

The signs have been delivered, and installed on the Green.

#### SNH parking outside Magpie Cottages

There has been no progress with South Northants Homes. Ann Mackness, who was on the working party, has advised she wishes to stand down. The council thanked her for her contribution to the working party.

#### <u>Pocket Park</u>

The second stage application has to be returned by 14<sup>th</sup> September. The committee are still waiting for an acknowledgement from SNC that planning permission is not needed. The Parish Council fully support the work that is being done and will assume responsibility for maintenance afterwards. This was proposed by Cllr Pollak, seconded by Cllr Kellett and all the councillors voted in favour. Cllr Waite is working on the plan to be forwarded to Cllr Osborne.

#### Finance Report

a) To approve the following payments: Cheques for approval

£517.00 to RD Landscapes Ltd £285.60 to Parish Clerk (hours) £21.08 to Parish Clerk (mileage)

The payments were approved and cheques raised accordingly. They were proposed by Cllr Powell and seconded by Cllr Pollak.

#### b) To agree and sign an amendment to the Annual Return 2009/10

The Annual Return had been returned for an amendment to be made. Page 2, box 10 the outstanding capital balance of all loans at 31 March should read £32,937K and not £33,520K. It was agreed the amendment should be made and it was initialled by the Clerk and Chair.

The external auditor has also asked why the reserves are so high. It is acceptable to build up reserves if the council is saving for a particular project. The Clerk to reply that the three identified accounts, Pocket Park, Recreation Fund and Burial Plot Fund are reserved for particular projects. £1200 has been allocated for projects such as the village shop, trees and Shrubs, Castle Green and Pocket Park maintenance. The council are also considering replacing the street lighting which will have to be carried out before 2020.

#### Planning Applications

One new application had been received since the last meeting:

• *S/2010/1009/TCA, fell one ash tree at The Thatched House, Manor Road.* This is currently being considered by the council.

Decision notices had been received for:-

- *S/2010/0244/FUL, Erection of a four bay garage with two home offices above at Dial House Farm, Magpie Road.* This planning application went to appeal and has been dismissed by the Planning Inspectorate.
- *S/2010/0782/FUL and S/2010/0783/LBC, Demolition of conservatory and replacement with flat roofed stone extension. Pitched roof over part of existing flat roofed kitchen extension (retrospective) at the Old Vicarage, Magpie Road.* Approved by SNC.
- *5/2010/0386/FUL, Change of use of land from agriculture to garden and paddock at Barrowhill Barn, Barrow Hill, Banbury Lane.* This was refused by SNC.

#### Correspondence

Letter from Brackley Area Volunteer Car Service (BAVCS) to advise about their service and expansion plans. BAVCS recruit volunteers who use their own cars to take people to essential appointments. The service is partially funded by the County Council. There are three registered passengers in Sulgrave and BAVCS asked if the Parish Council could consider making an annual contribution to support this invaluable service. The council asked if the Clerk could contact the three registered passengers to gain feedback from them and this would be carried forward to the next meeting.
